- 2. Verification of the documents and submission of fee for admission will be held on the spot at the UGB Campus on a first come first serve basis, subject to availability of seats. All the candidates have to be present at the University campus on the scheduled date and time.

- 4. Physical Verification of documents will be held in presence of faculty members of the respective Department.
- 5. In case of non-availability of the applicants in the Home Category, the seats will be incorporated into the Open Category and vice versa.
- 6. If a candidate fails to pay the requisite admission fee within the stipulated time, then the admission will be automatically cancelled. The candidate will not be considered for any further admission for the same subject.
- 7. Final Admission will be confirmed only after depositing the requisite fees and successful verification of all academic testimonials.

- 8. In case the information furnished at any stage of the application and admission process is found to be false or incorrect or if there is any discrepancy/mismatch between the information furnished at the relevant section and the certificates/documents produced at the time of admission/verification, the provisional admission offered to the candidate shall stand cancelled with immediate effect without assigning any further reason.
- 9. If any candidate fails to apply the Online Form of Counseling (OFOC) or fails to pay the required Admission Fee within the specified time, then no further opportunities will be given to the candidate.

- 11. The decision of the University Authority will be the final in all cases.
